A foreign driver's licence issued in a language other than English must be accompanied by a certified English translation of the licence or a current International Drivers Permit. Both the International Drivers Permit and the drivers national drivers licence must be presented at the time of rental.</p> <p><b>Vehicle Cover:</b> Vehicle Insurance is included in the price, subject to damage excess.</p> <p><b>Personal Accident Insurance:</b> PAI is optional and not included in rental, it is payable on collection of vehicle.</p> <p><b>Price Does not Include:</b> Fuel Optional Extras(child seat, etc.) <i>All extras are subject to Government stamp duty and GST at a rate of 10%.</i></p> <p><b>One-way Rental:</b> You can drop off your car at most Hertz offices throughout Australia.
